

Criminal Background Checks (CBCs)

Board-by-Board Overview

- 54 state medical boards conduct criminal background checks as a condition of initial licensure
 12 state medical boards conduct criminal background checks only as required by the Interstate Medical Licensure Compact
 - 52 state medical boards require fingerprints as a condition of initial licensure
 - 13 state medical boards require fingerprints only as required by the Interstate Medical Licensure Compact
 - 58 state medical boards have access to the FBI's NCIC database
